What is a standardized drink?

12 ounces of beer or 4-5 ounces of wine or 1 ½ ounces of liquor – BAC .02

How long does it take for the body to process one standardized drink?

It can take roughly 1-2 hours before one standardized drink can be fully metabolized in the body.

Is there a faster way to sober up?

No. Cold showers, coffee, food, fresh air, or exercise have no effect on getting sober. Your body still has to metabolize the alcohol.

Are there products other than drinking alcohol that will register a Blood Alcohol Content (BAC)?

Some products such as cough syrups, mouthwash, breath sprays, non-alcoholic beer and tinctures contain alcohol. Most will register on breathalyzers, but will not last very long unless consumed.

Alcohol Impaired Driving

Blood Alcohol Content -

(BAC) Measures the number of grams of ethanol in every 100 milliliters of blood.

Funded by the National Highway Traffic Safety Administration with a grant from the New York State Governor's Traffic Safety Committee.

What affects Blood Alcohol Content?

Blood alcohol is affected by the amount of alcohol ingested, the time it takes to drink the alcohol, gender, weight, amount of food eaten, overall health, fatigue and genetics.

How is Blood Alcohol Content Measured?

Blood alcohol can be measured through chemical analysis of a person's blood, breath, urine or saliva.

How much can a person drink before becoming impaired?

There is no easy answer, any amount of alcohol will, to some degree, affect a person's ability to drive.

No excuses!

- "I feel fine to drive."
- "I had one drink at lunch time."
- "I can handle my alcohol."

It only takes one standard drink to begin impairment.

Level of Blood Alcohol Content and how it affects driving tasks:

- .02 -.03 Reduced reaction time and divided attention. Drowsiness. Decline in visual functions
- .04-.05 Clouded judgment, impairment of the sensory motor skills, increased risk taking. Difficulty steering. Reduced response to emergency driving situations.
- .06-.07 Impaired tracking difficulties, impaired vision and hearing. Difficulty detecting danger, inability to focus, and perception impaired.
- .08-.10 Information processing deficit, risky decision making, problems with speed control, poor/slowed coordination.
- .10-.12 Reduction in concentration attention and perception. Reduced ability to maintain lane position and brake correctly.
- .13-.15 Unable to function behind the wheel.
 Gross motor impairment and lack of physical
 control in vehicle. Blurred vision and auditory
 information processing capability. Judgment and
 perception are severely impaired.
- .16+ Feeling dazed/confused or otherwise disoriented. All mental, physical and sensory functions are severely impaired.

Additional Penalty Information

The fines listed do not include the state mandated surcharges or crime victim assistance fees.

The Department of Motor Vehicles determines when your license can be restored. Its restoration or re-instatement, based on state law or regulation is not automatic. You must reapply for your license and may have to pass a test.

Three or more alcohol or drug-related convictions or refusals within 10 years can result in permanent revocation with a waiver request permitted after a minimum of 5 years.

License penalties are different for persons under the age of 21 and those holding CDL licenses.

What is the .08% Standard for Driving While Intoxicated?

Blood Alcohol Concentration (BAC) is defined as the level of alcohol in the blood stream. As the number of alcoholic beverages consumed over a period of time increases, so does the BAC. At .08% BAC, virtually everyone, including habitual drinkers, experiences some degree of driving skill impairment affecting eye movement, judgment, coordination, concentration, and speed control.

In a study published in the Journal of Studies on Alcohol (May 2000), results showed that a driver with a .08% BAC can be up to 50 times more likely to die in a crash than if he was completely sober (.00% BAC). At .10% BAC – the former BAC limit for driving while intoxicated in New York State - the same driver would be up to 240 times more likely to die in a crash caused by drunk driving. The degree of impairment varies for each individual according to the amount of alcohol consumed, body weight, length of time spent drinking, and whether the person ate before or while drinking alcohol.

Nationally 3 out of 10 people will be in an alcohol related crash in their lifetime.

Always Be Aware of How Much You Drink!

Each of the following drinks contains an equal amount of alcohol ...



What the .08% BAC Means to the Average Driver:



The Degree of Impairment Depends on Four Basic Factors:

- 1 The amount you drink.
- 2 Whether you've eaten before or while drinking (food slows absorption).
- 3 Your body weight.
- 4 The length of time spent drinking.

Coffee cannot make someone sober. The person may be more awake, but just as intoxicated. Only time can make someone sober. It takes at least an hour per drink for the alcohol to leave the body's system.

Drivers at .08% BAC are four times more likely to cause a crash than .00% drivers.

Drivers at .15% BAC are twenty-five times more likely to cause a crash than .00% drivers.





If I Have an Ignition Interlock Device Installed, What Products Should I Avoid?

- Alcohol products beer, wine, hard liquor, etc.
- Foods cooked with alcohol contrary to popular belief, the alcohol does not "burn off" during cooking.
- Mouthwash, toothpaste, or tooth whiteners that contains alcohol.
- Perfumes, colognes, after-shave lotions.
- "Alcohol-free" beer and wine.
- Prescription medications asthma inhalers, elixirs
- Over-the-counter medications cough syrup and tinctures.

Check product labels before using.

New York's Zero Tolerance Law

Questions and Answers

Provisions of the Law

First time offenders driving while intoxicated (DWI) (.08 Blood Alcohol Content or more) or impaired by drugs while a child younger than 16 years old is in the vehicle may be charged with a Class E Felony punishable by up to four years in State Prison. Individuals charged will automatically have their license suspended pending prosecution.

Courts must sentence all drivers convicted of a misdemeanor or felony DWI to install and maintain an ignition interlock device for a least six months on any vehicle owned and operated by such driver.

What is an Ignition Interlock Device?

An Ignition Interlock Device (IID) is a breath analyzer installed into a vehicle to prevent a person from starting the engine, or in certain cases, to continue to operate a motor vehicle after having consumed alcohol. The driver must blow into the device before the vehicle will start. The device records the following:

- 1. Attempts to start the vehicle.
- 2. The alcohol level of the individual at the time of starting the vehicle.
- 3. The alcohol level at random
- 4. Date and times the vehicle is operated.
- 5. Attempts to circumvent the device.

Who Pays for the Device, Installation, and Maintenance?

The defendant pays all related costs unless the court determines that he/she cannot afford to pay for part or all of the related costs.

Costs run roughly \$3.00/day.

Violations, service calls, and missed appointments are extra.

When Must the Defendant Comply with the Installation?

The IID must be installed within ten business days after sentencing.

If the court issues a continuation of driving privileges (20 day stay upon sentencing), the defendant may not drive unless an ignition interlock device has been installed in the vehicle.

Is the IID Sentence Condition Required if the Defendant Does Not Own a Vehicle?

Yes. If the defendant does not own a vehicle, he/she is still prohibited from operating a motor vehicle without the IID including motorcycles.

Who is Eligible?

Interlock monitoring is mandated by the sentencing court as a condition of a DWI misdemeanor or felony.

Which Laws are Covered Under Ignition Interlock?

DWI – PER SE, DWI (BAC .08 or higher) (VTL§1192.2, 1192.3)

- 1st Offense (misdemeanor)
- Fine: \$500-\$1,000
- Up to 1 year in jail
- License revocation for six month minimum
- Requirement of Ignition Interlock

AGGRAVATED DRIVING WHILE INTOXICATED (BAC .18 or higher) (VTL§1192.2a(a))

- 1st Offense (misdemeanor)
- Fine: \$1,000 \$2,500
- Up to 1 year in jail
- License revocation for one year minimum
- Requirement of Ignition Interlock

AGGRAVATED DRIVING WHILE INTOXICATED WITH A CHILD Leandra's Law (VTL§1192.2a(b))

- 1st Offense (Class E Felony)
- Fine: \$1,000 \$2,500
- Up to 4 years in jail
- License revocation for one year minimum
- Requirement of Ignition Interlock
